# Balochistan: 15 killed, 9 injured in bus accident

**UTHAL (BALOCHISTAN):** At least 15 people were killed after the bus they were travelling in overturned near Uthal city of Lasbela district in Balochistan on Tuesday morning, local media reported. The accident took place on the Quetta-Karachi highway, Express

Tribune reported. Nine people were wounded in the accident. Among the deceased were five women, three children and seven men who are yet to be identified. The bus was en route to Karachi from Panjgur area of Balochistan.

# Myanmar lawmakers under house arrest

Hundreds of members of Myanmar's Parliament were under house arrest Tuesday, confined to their government housing complex and guarded by soldiers a day after the military seized power in a coup and detained senior politicians including the country's de facto leader Aung San Suu Kyi. One of the detained lawmakers said he and about 400 others spent a sleepless night, worried they might be taken away, but were otherwise OK. They were able to speak with one another inside the compound and communicate to the outside by phone, but were not allowed to leave the housing

complex in Naypyitaw, the capital. He said Suu Kyi was not being held with them. "We had to stay awake and be alert," the lawmaker told The Associated Press on condition of anonymity out of concern for his safety. He said police were inside the complex, where members of Suu Kyi's party and various smaller parties were being held, and soldiers were outside it. The coup came the morning lawmakers had gathered in the capital for the opening of a new parliamentary session. The military said the seizure was necessary in part because the government had not acted on the military's claims of fraud in November's elections — in which Suu Kyi's ruling party won a majority of the parliamentary seats up for grabs — and claimed the takeover was legal under the constitution. But the move was widely condemned abroad. The coup highlights the extent to which the generals have ultimately maintained control in Myanmar, despite more than a decade of talk about democratic reforms. Western countries had greeted the move toward democracy enthusiastically, removing sanctions they had in place for years. The takeover now presents a test for the international community. U.S. President Joe Biden called the military's actions "a direct assault on the country's transition to democracy and the rule of law" and threatened new sanctions. The U.N. Security Council is expected to meet about the military's actions on Tuesday. Suu Kyi's National League for Democracy party released a statement Tuesday calling for the military to honor the results of the election and release all of those detained — as have the leaders of many other countries. "The commander-in-chief seizing the power of the nation is against the constitution and it also neglects the sovereign power of people," the party said in a statement on one of its Facebook pages. —AP

Party demands Suu Kyi's release

The party of Myanmar's detained leader Aung San Suu Kyi called on Tuesday for her immediate release and for the military junta that seized power a day earlier to recognise her victory in an election in November. The Nobel Peace laureate's whereabouts remained unknown more than 24 hours after her arrest in a military takeover that derailed Myanmar's tentative progress towards full democracy.

# Pak SC orders release of accused from death cell

## DANIEL PEARL MURDER



The Supreme Court of Pakistan on Tuesday ordered immediate release of Ahmed Omar Saeed Sheikh, the prime accused in the murder of American journalist Daniel Pearl, from his death cell, notifying authorities to move him to a government rest house within two days. The Supreme Court was hearing a petition filed by the Sindh provincial government, appealing against the Sindh High Court (SHC) decision of December 24 to release the prime accused Omar Saeed Sheikh. As per the court's order, authorities have been told to keep Sheikh at a better location in the jail in an open room for two days before being transferred to the government rest house. The court has also ordered to ensure deployment of security around the rest house. However, the court has not allowed Sheikh to have access to a mobile phone or internet facility. The court has allowed the family of Sheikh to stay with him at the rest house from 8 a.m. to 5 p.m. "Sheikh should not have access to the outside world from the rest house. He should be allowed to spend the 'Kashmir Day' with his family members", read the court's order.

The decision came after Pakistan's top court again rejected the government's appeal to suspend the SHC's verdict on the acquittal of the accused, stating that the federal government could file an appeal against the SHC's decision. "How can the federal government object to the decision of the Sindh High Court?" questioned the Sindh Advocate General. However, the judges maintained "Ahmed Omar Sheikh and other detainees cannot be called as accused". The case of Daniel Pearl's murder has become a testing assessment for Pakistan as the United States has raised serious reservations on the court's decision to acquit the suspects and later to retain the SHC's decision by Pakistan's top court. —IANS

# China attempting to intimidate neighbours, US concerned

In its first response to the China-India border standoff, the Biden administration has voiced concern over Beijing's ongoing attempts to "intimidate" its neighbours and said it was closely monitoring the situation. A top official of the new Biden administration also asserted that the US will stand with its allies to advance its shared values in the strategically-vital Indo-Pacific region. "We are closely monitoring the situation. We note the ongoing talks between the governments of India and Chi-

attempts to intrude into Indian territories and occupy it. "The United States is concerned by Beijing's pattern of ongoing attempts to intimidate its neighbours," Horne said. "We will stand with friends, partners and allies to advance our shared prosperity, security and values in the Indo-Pacific region," he added. This is the first response of the Biden administration on the India-China border clashes. Former vice president Joe Biden, a Democrat, was inaugurated as the 46th US President on January 20.

# Biden to sign orders to review Trump policies

US President Joe Biden will sign three executive orders on Tuesday on immigration, including creating a task force to reunify families that were separated at the border by the Trump administration's policies, and to ensure that the legal immigration system operates fairly and efficiently. According to the White House, Biden believes that "immigrants are essential to who we are as a nation and critical to American aspirations for the future." The previous Trump administration enacted hundreds of policies that run counter to American histo-



ry, it said. "This Executive Order will elevate the role of the White House in coordinating the federal government's strategy to promote immigrant integration and inclusion, including re-establishing a Task Force on New Americans, and ensuring that the legal immigration system operates fairly and efficiently," the White House said.

# Moscow court hands Navalny 2.5-yr sentence

A Moscow court on Tuesday sent Russian President Vladimir Putin's biggest critic Alexey Navalny to prison for two-and-a-half years. CNN reported the verdict was announced after a heated hearing in which the Kremlin critic ridiculed claims he broke his parole conditions while in a coma and denounced Russia's leader as "Putin the poisoner." The Putin critic was previously handed a three-and-a-half-year suspended sentence in the 2014 case along with five years of probation. He had to spend five months in Germany recovering from Novichok poisoning before his return to Moscow on January 17. Navalny blamed the attack

on the President and the Russian security services — accusations that were denied by the Kremlin repeatedly. Navalny has been arrested and detained several times but had until now avoided lengthy sentences. CNN further reported that Navalny has been arrested and detained several times but had until now avoided lengthy sentences.

While Navalny was recovering in Germany, Russian authorities had repeatedly threatened to jail him if he returned home. The opposition leader had ridiculed allegations that he could have better informed parole officers of his whereabouts while comatose, repeatedly being told by the judge to stop speaking and to the objections of prosecutors.

# WHO team visits animal disease centre in Wuhan

A World Health Organization team of international experts visited an animal disease center in the Chinese city of Wuhan on Tuesday as part of their investigation into the origins of the coronavirus pandemic. Team member Peter Daszak, a zoologist with the EcoHealth Alliance, said "excellent facilities, very informative meeting" from an open window as the group left the center in minivans. He also tweeted that they had met with staff in charge of livestock health in Hubei province, toured laboratories and had an in-depth discussion along with questions and an-



swers. Wuhan is the capital of Hubei. Further details of the visit were not announced in what has been a tightly controlled trip, with the media only able to glimpse

the team coming and going from its hotel and site visits. The team members wore full protective gear during Tuesday's visit. It's not clear if they wore similar full-body suits at the research institutes, hospitals and markets they visited on previous days. Outside their hotel and en route to and from visits, the experts have worn masks and professional or business casual attire. Intense negotiations preceded the WHO visit to Wuhan, where the first COVID-19 cases were detected in late 2019. China has maintained strict controls on access to information about the virus, possibly to avoid blame for alleged missteps in its early response to the outbreak.

# 59 houses wrecked in Oz wildfire

An out-of-control wildfire burning northeast of the Australian west coast city of Perth has destroyed at least 59 homes and was threatening more Tuesday, with many residents across the region told it is too late to leave. The 7,000-hectare (17,000-acre) blaze, which has a 80-kilometer (50-mile) perimeter, began on Monday and raged through the night near the town of Wooroloo, with the shores of Mundaring, Chittering, Northam, and the city of Swan affected. "Firefighters have done a remarkable job in some of the most challenging conditions that we've experienced in the metropolitan region for some time," Western Australia state Department of Fire and Emergency Services Commissioner Darren Klemm said.

# 6 killed in Oklahoma shooting

**MUSKOGEE (US):** Six people were killed early Tuesday in Oklahoma, including five children, and a person with a gun was taken into custody, police said. Officers responded about 1:30 a.m. to a call of multiple people shot at a home in Muskogee, about 45 miles (72 kilometers) southeast of Tulsa, police said in a press release. Once there, officers encountered a person with a gun who was later taken into custody. Officers at the scene found one man and four children dead, and a fifth child died at a Tulsa hospital, police said.

# Ready for new relations with US, says Iran FM

Iranian Foreign Minister Javad Zarif on Monday said that Iran is ready for a new relationship with the US — but the clock is ticking, reported CNN. In an interview with CNN, Zarif said the Biden administration has a "limited window of opportunity" to re-enter the

2015 nuclear agreement. "The time for the United States to come back to the nuclear agreement is not unlimited. The United States has a limited window of opportunity because President Biden does not want to portray himself as trying to take advantage of the failed policies of the former Trump administration," he said.

The Trump administration withdrew from the nuclear deal with Iran — known as the Joint Comprehensive Plan of Action (JCPOA) in 2018 after Tehran breached the uranium enrichment obligations. Last month, the Iranian regime announced that it had resumed enriching uranium up to 20 per cent purity at its Fordow nuclear facility — far

above the 3.67 per cent cap imposed by the 2015 pact, though still short of the 90 per cent that is considered weapons-grade, reported CNN. Meanwhile, Iran has made clear that any agreement now with the Biden administration will be contingent on a reversal of the harsh economic sanctions imposed by the Trump administration.

# Global Covid-19 cases top 103.3 mn

**WASHINGTON:** The total number of global coronavirus cases has topped 103.3 million, while the deaths have surged to more than 2.23 million, according to the Johns Hopkins University. In its latest update on Tuesday morning, the University's Center for Systems Science and

Engineering (CSSE) revealed that the current global caseload and death toll stood at 103,378,964 and 2,236,559, respectively. The US is the worst-hit country with the world's highest number of cases and deaths at 26,307,963 and 443,186, respectively, according to the CSSE.
