Opinion

- In view of complete erosion of net worth of the Company, the Holding Company has agreed to arrange the required financial support to maintain the Company as a going concern.
- Previous year the Company has paid to Bombay Stock Exchange re-instatement fees of Rs 44.95 Lacs. Consequently, the suspension in trading of equity shares of the Company has been revoked w.e.f. 29th April, 2024 and securities are available for trading in the "XT" Group.
- During the year BSE has imposed charges on the Company of Rs 39.77 lakhs due to non compaliance of Minimum Public shareholding in terms of regulation 38 of Securities And exchange board of India (Listing Obligation & Disclosure requirements) Regulations, 2015 (LOR). However the company has made an application for waiver of the charges imposed by BSE
