Textual Information(1)	<p>The Board of Directors of the Company are evaluating necessary steps to reduce the promoter holding below 75% and meet the minimum public shareholding requirements in terms of Regulation 38 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015. The Company has received an email in terms of Chapter VII Section VII-B SEBI circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 titled Non-compliance with the Minimum Public Shareholding (MPS) Requirements imposing fine of INR 7,43,400/-for the period from 29th April 2024 to 30th June 2024, of INR 10,85,600/- for the period from 1st July 2024 to 30th September 2024, of INR 10,85,600/- for the period from 1st October 2024 to 31st December 2024, fine of INR 10,62,000/- for the period from 1st January 2025 to 31st March 2025 and fine of INR 10,73,800/- for the period from 1st April 2025 to 30th June 2025. The Company has requested the BSE Limited to waive the said fine in view of negligible operations of the Company and losses incurred.</p>
