Textual Information()	<p>Apart from derating of the face value of equity shares from Rs. 10 to Re. 1 per share, the unsecured loan of the promoter/promoter group was converted into equity pursuant to the BIFR order in 2004 which resultant into increase of promoter/promoter group shareholding to 98.99% and subsequently, share capital held by the promoter/promoter group was reduced in accordance with the High Court Order in 2006, which lead to decrease in promoter/promoter group shareholding to existing shareholding 85%.</p> <p>After persistent follow up and multiple communications with BSE since 2011, the Company has been able to obtain trading and listing notice for the updated capital (i.e. 48,17,656 equity shares of Re. 1/- each bearing distinctive nos. 1 to 4817656) of the Company by BSE Limited vide its letter dated June 20, 2023 and BSE has also updated the revised capital of the Company in its records.</p> <p>The Company has also received In-Principle Approval for revocation of suspension in trading of equity shares vide BSE Letter dated LIST/COMP/SK/2379/2023-24 dated 22nd November, 2023 and is in the process of making necessary submissions in this regard.</p> <p>Post approval for revocation of suspension of trading, the Company will take necessary steps to reduce the promoter holding below 75% and meet the minimum public shareholding in accordance with SEBI circulars/ directives.</p> <p>The suspension in trading of equity shares of the Company will be revoked w.e.f. April 29, 2024 and pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 (Erstwhile SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2018/77 dated May 3, 2018), trading in the securities of the Company will resume in XT group.</p>
